1. Who we are

Monument Hill Kiwanis operates this website as a nonprofit service organization affiliated with [Kiwanis International](#). We use the site to share information about our club, volunteers, fundraisers, grants, scholarships, contacts, membership, volunteering, newsletter sign-ups, and donations

2. Information we collect

We may collect information you voluntarily provide, including:

- **Contact & membership inquiries:** name, phone, email address, postal address, message content
- **Event / volunteer / interest forms:** same types of fields shown on those forms
- **Email lists:** email address only if we offer signup
- **Donations:** if donations are processed on this site, payment information is handled by our third-party processor Stripe, and not stored by us

If you browse only and do not submit a form or log in as a member, we may still collect typical **technical info** described in Section 4.

3. Social media

If you interact with Monument Hill Kiwanis on *Facebook/X/Instagram/YouTube* those platforms collect data under their policies.

4. Automated data (cookies, analytics, logs)

We may use small text files, “cookies”, and/or analytics like Google Analytics or similar to understand traffic and improve the site.

- Cookies can often be refused or cleared in your browser; some site features might not work as well
- Hosting providers and security tools typically keep short-term logs (IP address, browser type, timestamps) for uptime and abuse prevention

5. How we use information

We use submissions to respond to inquiries, administer club activities consistent with Kiwanis's charitable mission and manage membership/rosters, comply with legal requests, operate and secure the website, compile aggregate statistics without publicly identifying individuals unless you've consented (e.g. published directory opt-ins).

6. Sharing

We do not sell personal information.

We share data only as appropriate when:

- You ask us to (e.g. referring you to Kiwanis International or a district/contact)
- Service vendors assist us under contracts that restrict use
- Law requires disclosure
- *Kiwanis International / Kiwanis Rocky Mountain District 4* needs limited contact/club-admin data for charters, directories, billing, governance—only as customary in Kiwanis and as we're allowed to disclose

7. Links

Our site links to *Kiwanis.org* and other organizations; their privacy statements apply once you leave our site.

8. Data retention

We keep submissions and correspondence only as long as needed for the purpose. Automated logs may expire sooner per hosting default.

9. Security

Reasonable safeguards are applied for a volunteer-run nonprofit site (SSL, limited admin access, updates). No online system is 100% secure.

10. Children's privacy

Kiwanis works with youth through programs such as **Key Club, K-Kids Builders Club, scholarships**.

Parents/guardians are encouraged to supervise minors' online submissions. **[If you knowingly collect identifiable information from minors on the site, describe COPPA-compliant consent or clarify you do NOT collect directly from kids under 13 without parental consent. ****

11. Colorado & U.S. visitors

Colorado privacy law such as **the Colorado Privacy Act** may apply. Residents may **email** monumenthillkiwanis@gmail.com with questions **[and if CPA applies, include rights summaries your counsel approves—for many small nonprofits the scope is narrow; don't invent rights. ****

Our club's relationship with [Kiwanis International](#) has its own bylaws/code of ethics/privacy materials. See kiwanis.org/privacy for practices.
